



## Participant Information Sheet (Version 4.0 – 07/07/2020)

### ***Drinks:Ration* app**

You are being invited to participate in a research study. Before you decide whether to participate, it is important for you to understand why the research is being done and what it will involve. Please take time to read the following information carefully and feel free to ask us if you would like more information or if there is anything that you do not understand. Please also feel free to discuss this with your friends, relatives and GP if you wish. We would like to stress that you do not have to accept this invitation and should only agree to take part if you want to.

#### **Invitation to take part**

We would like to invite you to take part in a study on the use of a smartphone application to **manage and monitor** alcohol consumption in ex-serving personnel.

If you take part in this study you will be asked to download and use a smartphone app for a minimum of 1-month, and to answer questions about your drinking and mental health 5 months later. A small number of participants will be randomly selected and invited to an interview to find out what they thought about the app.

#### **Why have I been invited to take part?**

You have been invited to take part in this study because you **have received treatment through Combat Stress** between 2017 and 2019, and you have given consent for researchers to contact you.

#### **Who is doing this research?**

This study is being conducted by the King's Centre of Military Health Research based at King's College London in collaboration with the University of Liverpool and Combat Stress and is funded by the Forces in Mind Trust. King's Centre of Military Health Research has been conducting research into the health and wellbeing of current and former members of the UK Armed Forces and their families since 1996. King's Centre of Military Health Research is independent of the Ministry of Defence.

#### **Do I have to take part?**

**No, it is your choice.** You do not have to take part, and if you do decide to participate, **you are free to withdraw from the study or uninstall the *Drinks:Ration* app at any time**, without giving a reason. Whether or not you decide to take part will not affect the healthcare you receive in any way. We will not disclose to Combat Stress if you or do not take part in this study.

#### **What will I be asked to do?**

If you decide to participate in this study, you will be invited to download our app called *Drinks:Ration* via the Apple or Google app store. Once you have downloaded the app you will be asked to scan a unique QR code which will allow you to register an account. Once you have registered an account, you will be asked to consent to us collecting additional information. This information includes your location

(recorded using your mobile phone GPS location) at the time of recording an alcoholic drink or drink free day, allow us to send you notifications and access to physical activity data (recorded by Apple Health and Google Fit). You are not required to install or use Apple Health or Google Fit to take part in this study, if you consent to allow us to access data held by these apps, we will collect information related to heart rate and fitness activities which include walking, running and swimming. You can decide **not to share any of this information** with us and you can **change your mind at any time** via the 'Settings' tab of the *Drinks:Ration* app.

The app will also sometimes send you notifications to either fill out some questions about your mood, environment and health or to provide supportive messages to help you reduce your alcohol consumption. If you prefer not to receive these notifications, you can turn them off within the app.

You will be asked to use the app for a **maximum of 6 months**, at the end of 6 months, your account will be disabled, and you will be asked to uninstall the app. At the end of the study, you may be asked to take part in an interview and asked what you found easy and difficult when using the app. This will take approximately **60 minutes**. We will provide more information about this interview if you've been selected.

### **Who will have access to my data and how will it be used?**

King's College London is the sponsor for this study based in the United Kingdom. We will be using information from you in order to undertake this study and will act as the data controller for this study. This means we are responsible for looking after your information and using it properly. King's College London will keep identifiable information about you for 7 years after the study has finished.

Your rights to access, change or move your information are limited, as we need to manage your information in specific ways for the research to be reliable and accurate. If you withdraw from the study, you have the option to delete your data or allow us to use the data we have already collected from you. If you decide to withdraw, this **must be done by the 1<sup>st</sup> August 2021** after which data will be extracted and used for analysis. To safeguard your rights, we will use the minimum personally-identifiable information possible. You can **withdraw or delete your data at any time** by visiting the 'Settings' tab of the app. You can find out more about how we use your information by contacting Daniel Leightley (daniel.leightley@kcl.ac.uk).

Combat Stress, as a collaborator for this study, will manage recruitment on behalf of King's College London. At no time will name, postal address, email address and telephone number be shared with King's College London. Only information you consent to provide through the *Drinks:Ration* app will be shared with King's College London. The only people in King's College London who will have access to information that identifies you will be people who need to contact you to check on your progress throughout the study or audit the data collection process. King's College London will keep identifiable information about you from this study for 7 years after the study has finished.

To maintain your anonymity, your name will be replaced with a code, and the information collected from the app will only be associated with this code. Your data will be securely stored on servers managed by the King's Centre for Military Health Research, King's College London, and also on 3rd party servers, which can provide additional security and backup. This data will not be linked back to your personal information.

Information you provide via the app, such as drinks diary, questionnaire responses and, if permission is given, activity data, will be checked and followed-up on by the research team if information is

revealed which suggests a risk of harm to yourself, we may call you to ask further questions and discuss options.

In the unlikely event that you lose capacity to consent during the study, you will be withdrawn, but any data collected up until this point may still be used. You can voluntarily withdraw from the study at any time.

If you participate in any optional interviews to tell us about your experiences of participating, the interview recordings may be sent to external transcribers who will be asked to sign a confidentiality agreement before listening to any of the recordings. Only your participation code will be associated with these interviews, not your name, so information you provide will be anonymous.

Where this information could identify you, the information will be held securely with strict arrangements about who can access the information. The information will only be used for the purpose of health and care research, or to contact you about future opportunities to participate in research. It will not be used to make decisions about future services available to you, such as insurance. Where there is a risk that you can be identified, your data will only be used in research that has been independently reviewed by an ethics committee.

### **What are the risks and disadvantages of taking part?**

There are unlikely to be any direct risks to you if you take part in this study as the app is designed to reduce your consumption of alcohol. However, if we detect that you may be drinking at a harmful level, we may get in touch to provide guidance and support. If you have any negative experience as a result of taking part in this study, please let us know immediately by contact Daniel Leightley ([daniel.leightley@kcl.ac.uk](mailto:daniel.leightley@kcl.ac.uk)). There is a small risk that the technologies used in this study could be hacked, however this risk is the same as with any smartphone or commercial app. The encryption and data de-identification processes have been put in place to minimise any risk to you in the unlikely event of hacking.

### **What are the benefits of taking part?**

Taking part in this study may benefit you directly and help you to reduce your drinking. You will also be helping the ex-serving community more widely by helping us to test a health intervention which can benefit others in the future.

### **What will happen to the results of the research?**

The results of this study will be published in scientific journals and presented at conferences. You will not be **identified personally** in any report or publication.
